### MENTAL HEALTH SURVEY UPDATE

Associate Superintendent Irvine provided the Board with an overview of the results of mental health focused surveys completed by students and parents. In March, 70 % (seventy percent) of Northern Lights Public Schools (NLPS) students in Kindergarten through Grade 12 completed a mental health survey. In late March/early April, 437 parents, representing 12.8% of the division's students, had the opportunity to complete a survey with questions about school atmosphere, student mental health services, student mental health experiences, and parent learning opportunities. She shared highlights as well as areas of concern for both. Received as information only.
