- Fees for the 2024-2025 school year are \$3251.20 - \$2250.00 Federal Affordability Funding = \$1001.12
- Fees are reduced by the Federal Affordability Funding in the amount of \$225 per month from September 2024 -June 2025 (Total fee reduction = \$2250.00)
- All payments to be paid through School Cash Online
- Fee can be paid in one sum in September or in payments of \$100.12 on a monthly basis for ten months (September - June)
- \$560.00 deposit** required at time of registration to secure space in the program and will be refunded, less admin fee, at the end of the year.
- ★ Class dates and times subject to change.
- ★ Deposit is non-refundable once it is received no exceptions
- ★★ Daycare Affordability Grant funding will be proportionately reduced to ensure that the parent fees are not less than \$217.50 for children registered to attend 100+ hours and not less than \$100.00 for children registered to attend 50-99 hours, before subsidy. The minimum parent fees were determined by the government using the target of \$10 per day by 2026 and the average number of work days in a month.
